Annex 1 – Mandatory conditions

Mandatory conditions where the licence authorises the supply of alcohol:

- (1) No supply of alcohol may be made under the premises licence -
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Annex 2 - Conditions consistent with the operating schedule

- 1. Patrons will be reminded to leave the premises quietly and have regard to the needs of local residents.
- 2. With regards to live music, performances of dance & provision of facilities for making music, this is limited to performances by belly dancer (s) or small dance troupe (up to 3 persons) &/or musicians (up to 3 persons) for up to two performances each maximum 30 minutes duration.
