Annex 1 – Mandatory conditions

1. No supply of alcohol may be made under the premises licence –
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
3. The admission of children to the exhibition of any film shall be restricted according to the classification of the film by the film classification body designated by section 4 of the Video Recordings Act 1984.
4. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children–
 - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to–
 - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
 - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
 - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);

- (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;
 - (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on–
 - (i) the outcome of a race, competition or other event or process, or
 - (ii) the likelihood of anything occurring or not occurring;
 - (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
5. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
 6. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
 7. With effect from 1 October 2010: (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
 8. With effect from 1 October 2010: The responsible person shall ensure that–
 - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures–
 - (i) beer or cider: ½ pint;
 - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
 - (iii) still wine in a glass: 125 ml; and
 - (iv) customers are made aware of the availability of these measures.

Annex 2 – Conditions consistent with the operating schedule

The licences are granted subject to the Regulations and Conditions made by the Licensing Authority currently in force and any additional special conditions set out below.

1. For each category of entertainment, the number of persons to be admitted to the premises shall not exceed 127.
2. There will be no adult entertainment that may give rise to concern in respect of children.

GENERAL CONDITIONS

1. A copy of the Licensing Authority’s Regulations and Conditions shall be kept readily available on the licensed premises for use by the person or persons in charge of the premises.
2. The sound level at the centre of the hall shall not exceed 90dB (a) when expressed as an 8 hour LAeq and/or a peak sound pressure of 200 pascals (140dB).

3. When amplified music or a public address system is in use, the doors and windows of the room being used for public entertainment shall be kept shut to minimise disturbance to local residents.
4. Any outbreak of FIRE, however slight, must be reported to the Licensing Authority immediately.
5. Socket outlets for use with temporary or portable electrical equipment on or in the vicinity of any stage area and other circuits associated with spotlights or other stage lighting equipment shall be protected by one or more residual current devices, as necessary, having an adequate load current rating and a 30 milliamp tripping current.
6. If licensed for stage plays, at least fourteen days notice shall be given to the Licensing Authority of any proposed stage performance to enable the necessary inspections of potential fire hazards to be carried out, e.g. the dressing facilities for performers, the storage of props, scenery etc.

The following General Licensing Conditions are to be observed during Public Entertainment at the above premises.

1. These general conditions are to be kept posted on some conspicuous place at the principal entrance of licensed premises.
2. Police officers, Fire officers and authorised persons of the Licensing Authority shall be allowed access at all reasonable times to all parts of the premises.
3. The Licensee shall in all respects conduct the premises in a decent, sober and orderly manner.
4. The Licensee or some responsible person nominated by him in writing, not being a person under twenty-one years of age, shall be in charge of and present in the premises at all times when the public are on the premises.
5. All exit doors shall either open outwards or be fastened open so long as members of the public are present.
6. No obstructions, whether permanent or temporary, shall be allowed in any exit doors, exit ways, (whether corridors or staircases), external passageways, gangways, foyers, lobbies or entrance halls. Persons seeking admission shall not be allowed to form queues, which obstruct such exit doors etceteras.
7. All lavatories, cloakrooms and WC's shall be kept in a clean, sanitary condition and maintained in good working order.
8. A notice printed in large type and indicating the position of the nearest telephone and the method of calling the fire brigade shall be kept posted on some conspicuous part of the principal entrance of the premises.
9. Primary maintained general lighting shall:
 - (a) be kept in use throughout the premises so long as members of the public are present;
 - (b) be adequate by itself to enable all persons on the premises to see their way out of the premises.

10. The safety lighting shall:

- (a) be kept in use throughout the premises so long as members of the public are present;
- (b) be adequate by itself to enable all persons on the premises to see their way out of the premises.

11. Proper provision shall be made for ventilating all parts of the premises used by the public, the performers and the staff.

12. The Licensee shall be responsible for ensuring adequate control over persons and vehicles using parking facilities within the curtilage of the premises or under his direct control.
